Women's Initiatives for Gender Justice (WIGJ) is an international feminist human rights organisation that advocates for gender justice in and through criminal law and justice mechanisms.

Consultancy overview:

The Campaign Coordinator (Legal & Advocacy) will lead WIGJ's joint advocacy strategies in facilitating NGOs' coordination around gender justice in international criminal law. The coordination will involve collecting information on developments; managing relationships with key stakeholders, including international legal bodies, civil society organizations, academia and survivor groups, to foster a collaborative environment for addressing gender justice; sharing updates and resources with key stakeholders; facilitating meetings and opportunities for joint advocacy; proposing first drafts for joint advocacy papers; and other activities as discussed with the WIGJ and team members.

Key outputs:

- WIGJ representation in various existing and emerging initiatives to enhance cooperation and coordination among NGOs (and other practitioners) to advance our mandate:
 - Coordinate the establishment and maintenance of a platform for civil society engagement, ensuring effective communication and resource sharing, including through the CICC Advocacy Team on Gender Justice;
 - Manage the production of advocacy materials and coordinate the dissemination of research findings and policy recommendations;
 - Facilitate knowledge exchange sessions and workshops between different stakeholders to enhance understanding and advocacy of gender justice issues;
 - Lead the development and execution of advocacy strategies to support gender justice initiatives; and
 - Monitor and report on advocacy progress and impact, providing insights and recommendations for future actions.
- Multiple (exact amount to be determined) awareness raising and strategic communication campaigns around our various campaigns related to sexual violence and gender justice;
- 1-2 Advocacy papers on legislative and policy gaps in the implementation of The Hague Principles on Sexual Violence;
- Project management support of WIGJ's in-country initiatives;
- Input to WIGJ's Evaluation and Reporting, including MEAL.

WOMEN'S INITIATIVES FOR GENDER JUSTICE

Offers will be evaluated based on the following technical criteria:

- 1. Experience and Expertise in Gender Justice Advocacy (30%)
- 2. Project Management Skills (20%)
- 3. Communication and Coordination Abilities (20%)
- 4. Research and Policy Analysis (15%)
- 5. Monitoring and Evaluation (MEAL) Expertise (15%)
